All individually metered SUEZ Water New York customers in Rockland, Orange and Putnam counties are eligible to apply. Rebate applications must be completed in full and are subject to verification and availability of funds. Please allow six (6) to eight (8) weeks after receipt of complete documentation for payment of approved rebates. SUEZ Water New York does not warrant, endorse, or assume liability for the quality or performance of the installed equipment related to purchases under this program. SUEZ Water New York reserves the right, at its sole and absolute discretion and at any time, to change any or all of the rebate program policy, or to cancel the rebate program without prior notice. Applicant must submit a copy of the sales receipt with the application. Customer shall be responsible for all taxes that may be imposed with respect to the rebate offer. Incomplete applications cannot be processed and will be returned for additional information. Rebates will only be paid for up to the purchase price of the device(s). This does not include tax, shipping, or installation.
